CIRCULAR

In accordance and compliance with the decision of the Sindh Cabinet, all processes related to the registration and renewal of registrations, including the issuance of registration certificates, will henceforth be carried out exclusively through an online system.

In this context Sindh Business One Stop Shop (S-BOSS), in collaboration with The Competitive and Livable City of Karachi (CLICK), Investment Department, Government of Sindh has developed e-Licensing portal i.e. sboss.business.gos.pk for submission of online application and issuance of e-certificates.

All principals and administrators of privately managed schools across Sindh are hereby informed that, applications for registration and renewal of registration shall no longer be submitted through the Directorate's web portal. Instead, all such applications must now be submitted exclusively via the official web portal of the **Sindh Business One Stop Shop (S-BOSS)** sboss.business.gos.pk.

The SBOSS will provide assistance through three primary channels in this regard Monday to Friday, 09:00-18:00:
