**SUBJECT: IMPLEMENTATION THE STATUTORY TEN PERCENT FREESHIP TO
DISADVANTAGED CHILDREN IN ACCORDANCE WITH 'THE SINDH
RIGHT OF FREE AND COMPULSORY EDUCATION ACT 2013'.**

Please find enclosed herewith copy of order dated: 09-10-2025 passed by the Honourable High Court of Sindh Bench at Sukkur in Const. Pett No. D-1592 of 2025. The operative part of the order includes the following instructions from the Honourable High Court:

1. The Secretary, School Education and Literacy Department, Government of Sindh, is directed to ensure strict enforcement of the Sindh Right of Children to Free and Compulsory Education Act, 2013, particularly Section 10 thereof.
2. The Directorate of Inspection and Registration of Private Institutions shall within three months conduct a comprehensive audit and inspection of all registered private schools across the province of Sindh to ascertain whether they are providing free education to the requisite ten percent (10%) of enrolled students.
3. A detailed compliance report shall be submitted before the Additional Registrar of this Court within four months from today, indicating the schools found in violation of the law and the actions initiated against them.
4. In case any private school is found to have failed to comply with the mandatory provision, its registration shall be suspended or cancelled, in accordance with Section 12 of the Act.

5. *The Education Department is further directed to devise and publish transparent guidelines and monitoring mechanisms for continuous verification of compliance with the 10% free-education requirement.*

You are hereby directed to fully comply with the Order of the Honourable High Court of Sindh, both in letter and spirit, by providing at least 10% free-ships to disadvantaged students based on the total enrollment of the school. Moreover, district-wise monitoring committees will visit all privately managed schools within their jurisdictions to conduct a thorough free-ship audit. Therefore, all schools must have the relevant records ready for review during these visits. Any school found failing to comply with the Honourable High Court's Orders will face strict action under Section 8 (Cancellation or Suspension of Certificate of Registration) of "The Sindh Private Educational Institutions (Regulation & Control) Ordinance 2001 and Rules-2005."

It is further informed you that the Directorate of Inspection and Registration of Private Institutions Sindh has developed guidelines and monitoring mechanism for continuous verification of compliance with the 10% free-education requirement. (Copy enclosed)
