## SUBJECT: NOMINATION OF TEACHERS FOR MASTER TRAINING

Please refer to this Directorate letter No. DIT/I&R/PIS/EDU/GOS(412-20)/2023, dated: 12-4-2023, on subject captioned above.

In this context, it is stated that, according to Section 9 of the 'Equity in Education of Sindh Empowerment of Persons with Disabilities Act-2018,' all educational institutions are required to provide admission to children with disabilities without discrimination. Furthermore, they must ensure the accessibility of the campus and other facilities, as well as impart effective education that is most suitable to the needs of the students. The Act also mandates that all educational institutions detect learning disabilities in enrolled students at the earliest, enabling remedial measures to be taken for them. The aforementioned Section is reproduced below:

"The Education Department shall ensure full concession in admission fee, tuition fee and examination fee in all government education and vocational institutions and fifty percent in all private educational and vocational institutions to the children of person with disabilities and five percent seats shall be reserved for person with disabilities up to higher education level; provided that the children or person who suffers from disability shall also be entitled such concession as provided by this rule."

It is advised to provide education to the slow learner, mild autistic, boarder line cases, and Down syndrome children. Additionally, and provide the following:

 Steps to be taken for each points stated under Section 9 'Equity in Education of the Sindh Empowerment of 'Person with Disabilities' Act 2018.

- School provides inclusive education with their enrollment strength to assess the compliance of 5% reserved seats in every branch nominated for inclusive education.
- iii. Number of special educators /resource teachers hired to meet the demands of children with disabilities. The Department of Empowerment Persons with Disabilities will provide necessary training to that staff/teachers.

You are, therefore, directed to take all necessary steps outlined above to provide inclusive education to the differently-abled children and implement all conditions of Section 9 of "Sindh Empowerment of 'Person with Disabilities' Act 2018 in both letter & spirit and also propose the names of at least two teaching staff member from your schools designated for inclusive education on attached proforma. The recommended teachers will receive training from the Center for Autism, Rehabilitation and Training Sindh (C-ARTS), Department of Empowerment Disability Person, to serve as master trainers. C-ARTS will contact the school administration and the nominated teachers directly to coordinate the training.
