**SUBJECT: NATIONAL IMMUNIZATION DAYS (POLIO) CAMPAIGN IN SINDH 13th
TO 19th OCTOBER 2025.**

In continuation of this Directorate's letters No. DIR/I&R/PIS/SELD/GOS (2115-2123)/2025, dated 02-10-2025, and dated 10-10-2025, on the subject noted above, you are hereby directed as follows:

- i. All school administrations shall fully cooperate with the Polio Eradication and Health Department teams during their visits. Under no circumstances should delaying tactics be adopted, such as asking the teams to return the next day or claiming that the school administration is not prepared to facilitate vaccination on the same day.
- ii. The updated data of all students up to 5 years of age enrolled in the school must be readily available and provided to the Health Department teams upon their request to ensure smooth and accurate implementation of the vaccination drive.
- iii. In case any student aged up to 5 years is absent on the day the Polio Eradication Team visits the school, the administration shall provide the team with complete information and residential address of the said student to facilitate follow-up vaccination.
- iv. It is reiterated that **no prior consent from parents** is required for administering the polio vaccine. The vaccination process shall proceed in accordance with the guidelines issued by the Health Department and the Government of Sindh.
