SUBJECT: NATIONAL IMMUNIZATION DAYS (POLIO) CAMPAIGN IN SINDH 13th TO 19th OCTOBER 2025.

In continuation of this Directorate letter No. DIR/I&R/PIS/SELD/GOS (2115-2123)/ 2025, dated: 02-10-2025, on the subject noted above. In this connection, it is once again informed you that the Emergency Operations Center for Polio Eradication and Immunization, Government of Sindh, is going to launch a National Immunization Days campaign across Sindh, (in 30 districts).

Therefore, the administrations of all privately managed schools are hereby directed to extend their full cooperation to the polio eradication teams during the forthcoming campaign, which will be held from 13th October to 19th October 2025. Non-cooperation with the health department teams shall not be tolerated. If any institute that refuses or fails to cooperate with the polio vaccination/eradication teams, stern action shall be initiated under *The Sindh Private Educational Institutions* (*Regulation & Control*) *Ordinance*, 2001, and *Rules*, 2005.
