SUBJECT: SUB-NATIONAL IMMUNIZATION DAYS (POLIO) CAMPAIGN IN SINDH 13th TO 19th OCTOBER 2025.

In continuation of this Directorate letter No. DIR/I&R/PIS/SELD/GOS (2115-2123)/ 2025, dated: 02-10-2025, on the subject noted above. In this connection, it is once again informed you that the Emergency Operations Center for Polio Eradication and Immunization, Government of Sindh, is going to launch a National Immunization Days campaign across Sindh, (in 30 districts).

Therefore, you are hereby directed to issue directions to the administrations of all privately managed schools of your concern region to extend their full cooperation to the polio eradication teams during the forthcoming campaign, which will be held from 13th October to 19th October 2025. Non-cooperation with the health department teams shall not be tolerated. If any institute that refuses or fails to cooperate with the polio vaccination/eradication teams, stern action shall be initiated under *The Sindh Private Educational Institutions (Regulation & Control) Ordinance*, 2001, and Rules, 2005.

You are further directed to nominate district wise Focal Persons in this regard. All Focal Persons shall attend the daily evening meeting at the office of the concerned Deputy Commissioner. During these meetings, they must discuss and address all issues related to the ongoing polio vaccination campaign in private schools. Any challenges or matters requiring attention should be promptly communicated and resolved in coordination with the health department teams.
